Getting started

- Choose your designees – up to three.
- Select one as the primary designee.
This is the only one of the three who may serve as a club officer.
- Fill out the enclosed application forms, and submit to **office@rotary13.org**.
- Once membership is approved, the three designees will participate in a brief orientation session, then be introduced at the club meeting that same day. A mentor will be assigned to your group.
- Dues cover the lunch of one person per week. If additional designees wish to attend the meeting, they pay the cost-to-the-club amount for lunch.

- Networking with other civic and business professionals and not-for-profit leaders in a club that has been serving Kansas City for more than 100 years
